Subject: Motivational letter for the position of the Secretary-General of CDN

Dear friends,

My name is Filip Janković, and I am currently serving as a member of the Executive Committee (EC) of CDN. I am writing to express my candidacy for the position of the Secretary-General, as I remain committed to strengthening our network and supporting our member organizations in their political and activist struggles.

During my last mandate in the EC, I served as the Center-East responsible, ensuring regular and effective communication between CDN and its member organisations in the region. Through this role, I have worked closely with activists and organizations to amplify their voices and provide necessary support in their efforts. Most recently, I was representing CDN on the consultative meeting for the International Youth NGOs in Budapest, where I represented CDNs position in the shaping the New Democratic Pact for Europe.

My experience extends to strategic planning, event organisation, and fundraising, being a member of the organisational teams for the Training of Trainers in Belgrade and for the General Assembly in Riga. Beyond my engagement in CDN, I have been actively involved in youth activism for over six years through various local, national, and international organisations.

I decided to run for Secretary-General because I firmly believe that now, more than ever, we must make our voices louder towards the institutions that shape our lives. We are seeing that Europe is facing challenging times with the re-election of Donald Trump and the resurgence of American isolationism, which directly benefits the Russian imperial state and its destabilizing ambitions. Trump's exploitation of Ukrainian resources only underscores the urgency of our fight for a free and sovereign Ukraine within its pre-2014 borders.

Now more than ever, I believe that we must push for Eastern Perspective, because time and time again we are reminded of the fact that in the game of global multipolar imperialism, it is the underrepresented communities that are the first ones to be targeted. We must not let that happen, and I believe that only if we lead our network to the position of being a visible, reliable and firm voice of Eastern European youth we can stay resilient.

To address these challenges, we need to commit not only to support our member organisations but also actively work to build international alliances that strengthen our network. With my experience in international activism, strategic planning, and political organising, I am confident in my ability to contribute to the CDN's work and to represent the diverse voices within our network.

I ask for your trust and support, so that together, we can continue to fight for a future worth living.

Subject: Vision statement for the position of the Secretary-General of CDN

Dear friends,

In a time marked by democratic backsliding, growing political polarisation, and shrinking civic space, the role of progressive youth networks has never been more important. Across Europe, young people continue to demonstrate a strong commitment to social justice, climate action, equality, and democracy. Yet, their voices are still too often underrepresented or instrumentalised rather than genuinely empowered. We can see this on the example of Serbia, where being stuck in a system that simply doesn't work and that led to multiple tragedies culminating in the Novi Sad disaster, led to gross violations of civil rights and liberties, where the rule of law, democracy and human rights still feel like a very abstract concept to an ordinary young person from Serbia.

I believe that the mission of CDN must be to transform this energy into sustained political influence, by organising more short-term events and by making our network more vocal and participatory. My vision is for CDN to become a politically relevant, organisationally strong, and financially stable network that empowers its member organisations, amplifies youth voices in European policymaking, and acts as a trusted progressive actor across the continent.

First, CDN should strengthen its political profile and visibility. Beyond reacting to political developments, the network should continue to proactively shape debates on key issues such as democratic resilience, social and economic justice, climate transition, and inclusive participation. Though, we must be aware of the context of young people from our region face - and that is that not everyone has the time or the opportunity to get engaged within CDN. We therefore must work on empowering our existing and to encourage the creation of new Action teams, to build the Council of Members to be one of the strongest bodies in the

organisation and to organise more events on which many different topics with more people can be tackled that should influence our political work.

During my mandate, I aim to establish a structured system for producing regular policy positions and joint statements, aimed at the European institutions and policymakers, developed as a result of our joint work through the Council of Members and the Executive Committee and with the close cooperation of our sister organisation, FYEG.

Furthermore, CDN should deepen its engagement with European institutions, political foundations, and like-minded networks. Our closest partner must remain the FYEG and the EGP, deepening the cooperation with them would be my utmost political priority, but we also must include organisations that tackle issues that we need to tackle as well, like: minority rights, student rights, European integration etc.

My leadership style will be collaborative and service-oriented. I see the role of the Secretary-General not as a centralised authority, but as a facilitator who enables others to contribute, take initiative, and succeed.

Financial stability is a precondition for independence and long-term impact. CDN should aim to diversify its funding sources by diversifying its funding sources and appealing to more political and institutional foundations. We must build a working relationship with the EU in order to also access EU funded projects, as this can enable us to tackle even more topics that are important to us. What also needs to be considered is the prospect of regional foundations that could strengthen our regional work.

Ultimately, my goal is for CDN to be a network where member organisations feel supported, heard, and empowered, and where we see a platform that truly represents our aspirations for a more democratic, just, and sustainable future.
